LEGAL NOTICE

The Township of West Milford Municipal Utilities Authority will hold a Public Hearing on Tuesday, February 17, 2009 at 7:00 PM in the Main Meeting Room of the Municipal Building, 1480 Union Valley Road, West Milford New Jersey 07480.

The purpose of the Public Hearing is to discuss the proposed rate increases to the sewer and water service charges in order to provide sufficient revenues to meet operating and debt service obligations. The West Milford Municipal Utilities Authority will give testimony and provide evidence that the proposed rate adjustments are necessary and reasonable. The sewer and water rate is an annual fee payable quarterly.
